MEMBERSHIP CATEGORIES

VOTING MEMBER: Any person who is employed as a paralegal and who in the course of their employment performs substantial paralegal functions under the supervision of an attorney and has performed these functions for a period of at least one (1) year. A voting member must be a resident of or employed in Lycoming County, or surrounding counties of Pennsylvania. A voting member is the only class of member who shall be entitled to hold office or to be a director on the Board. A voting member is entitled to one (1) vote in all matters including the election of officers and directors, which require the vote of the members of the LCPA.

AFFILIATE MEMBERS: Any person who (1) is employed as a paralegal or who in the course of their employment has performed substantial paralegal functions under the supervision of an attorney for less than one year; or (2) is employed as a paralegal educator; or (3) has been employed as a paralegal under the supervision of an attorney or paralegal educator; or (4) has completed a formal course of study, but who is not employed at the time of application for membership to the LCPA; or (5) any voting member who is not employed as a paralegal at the time of the annual renewal of such voting member's membership. An affiliate member may become a voting member upon satisfaction of the requirements for a voting membership. Affiliate members shall not be entitled to vote on matters requiring the vote of the members of the LCPA.

_____ **RENEWAL AFFILIATE MEMBER: \$55.00**

ASSOCIATE MEMBERS: Any person who is enrolled in a formal course of study leading to a position as a paralegal may become an associate member and upon satisfaction of the corresponding requirements may become an affiliate member or a voting member.

_____ **NEW ASSOCIATE MEMBERS: \$50.00**

_____ **RENEWAL ASSOCIATE MEMBERS: \$45.00**

SUSTAINING MEMBERS: Any firm, association, corporation, educational institution or other entity who is interested in supporting the objectives and purposes of the LCPA as stated in Article II, Section 2.2 of the LCPA By-Laws may become a sustaining member. Sustaining members shall not have voting elective or representative privileges, but shall be entitled to participate in the activities of the LCPA.
